個人專業投資者聲明書 INDIVIDUAL PROFESSIONAL INVESTORS DECLARATION

第1部分:個人專業投資者的分類

本人/吾等合資格被視為下文所述證券及期貨條例及專業投資者規則下的專業投資者,並同意被視為個人專業投資者(「個人專業投資者」)。

託管人在有關日期代其(無論單獨或連同其配偶或子女的聯名賬戶)持有的現金及/或證券投資組合不少於8,000,000港元(或等值外幣)的高淨值個人投資者,合資格作為專業投資者規則下的「專業投資者」。本人/吾等同意應要求提供充分的書面證明,以核證吾等的上述財務狀況。

Section 1: Classification as an Individual Professional Investor

I/We are qualified to be treated as a Professional Investor under the SFO and the Professional Investor Rules as described below and agree to be treated as such ("Individual Professional Investor").

A high net worth individual investor, either alone or with his/her spouse or children on a joint account, having a portfolio of cash held for such person or persons by a custodian and/or securities of not less than HK\$8 million (or its foreign currency equivalent) at the relevant date qualifies as a "professional investor" under the Professional Investor Rules.

I/We agree to provide documentary evidence sufficient to verify our financial status as above upon request.

第2部分:個人專業投資者的處理

成交單據、賬戶結單及收據

由於富喬鑫資本(香港)有限公司/富喬鑫國際投資有限公司(「JMC」)視本人/吾等為個人專業投資者,本人/吾等同意 JMC 不須按照證券及期貨(成交單據、戶口結單及收據)規則的規定向本人/吾等提供成交單據、賬戶結單及收據。儘管有此規定,本人/吾等理解 JMC 可繼續向本人/吾等提供若干資料,包括載有任何交易詳情的報表,即使 JMC 無責任提供該等資料。

為客戶提供資料

基於閣下同意被視為證券及期貨事務監察委員會持牌人或註冊人操守準則(「**守則**」)下的個人專業投資者, JMC 將無須履行守則的若干監管規定。儘管 JMC 於向專業投資者提供服務時可能部分或全部履行以下各項,惟 守則並無規定 JMC 履行以下各項:

- (a) 向個人專業投資者提供有關 JMC 的業務以及有關將與個人專業投資者聯絡的 JMC 僱員及其他代表 JMC行事的人士的身份和受僱狀況的資料;
- (b) 為個人專業投資者完成交易後,盡快向個人專業投資者確認有關該宗交易的重點;及
- (c) 向個人專業投資者提供關於納斯達克-美國證券交易所試驗計劃的資料文件。

個人專業投資者的處理

根據守則,個人專業投資者有權隨時向 JMC 發出書面通知,就所有投資產品或市場或其任何部分撤回被視為個 人專業投資者。

身份變更

倘個人專業投資者不再合資格被視為專業投資者規則下的個人專業投資者,則必須即時以書面形式通知 JMC。

Section 2: Treatment as an Individual Professional Investor

Contract Notes, Statements of Account and Receipts

As a consequence of JMC Capital HK Limited / JMC Capital International Limited ("JMC") treating me/us as an Individual Professional Investor, I/we agree that JMC is not required to provide me/us with contract notes, statements of account or receipts under the Securities and Futures (Contract Notes, Statements of Account and Receipts) Rules. Notwithstanding this requirement, I/we understand that JMC may continue to provide me/us with certain information, including statements setting out the particulars of any transaction, even though JMC is not obliged to do so.

Information for clients

Upon your consent to treatment as an Individual Professional Investor under the Code of Conduct for Persons Licensed by or Registered with the Securities and Futures Commission ("Code"), JMC will not be required to fulfil certain regulatory requirements under the Code. While JMC may perform some or all of the following in

providing services to Professional Investors, JMC is not required under the Code to do the following:

- (a) inform the Individual Professional Investor about JMC's business and the identity and status of its employees and others acting on JMC's behalf with whom the Individual Professional Investor will have contact:
- (b) confirm promptly with the Individual Professional Investor the essential features of a transaction after effecting a transaction for the Individual Professional Investor; and
- (c) provide the Individual Professional Investor with the documentation on the Nasdaq-Amex Pilot Program.

Treatment as Individual Professional Investor

Under the Code, the Individual Professional Investor has the right to withdraw from being treated as an Individual Professional Investor at any time in respect of all investment products or markets or any part thereof by giving written notice to JMC.

Changes in Status

The Individual Professional Investor must inform JMC in writing immediately if the Individual Professional Investor no longer qualifies to be treated as an Individual Professional Investor under the Professional Investor Rules.
